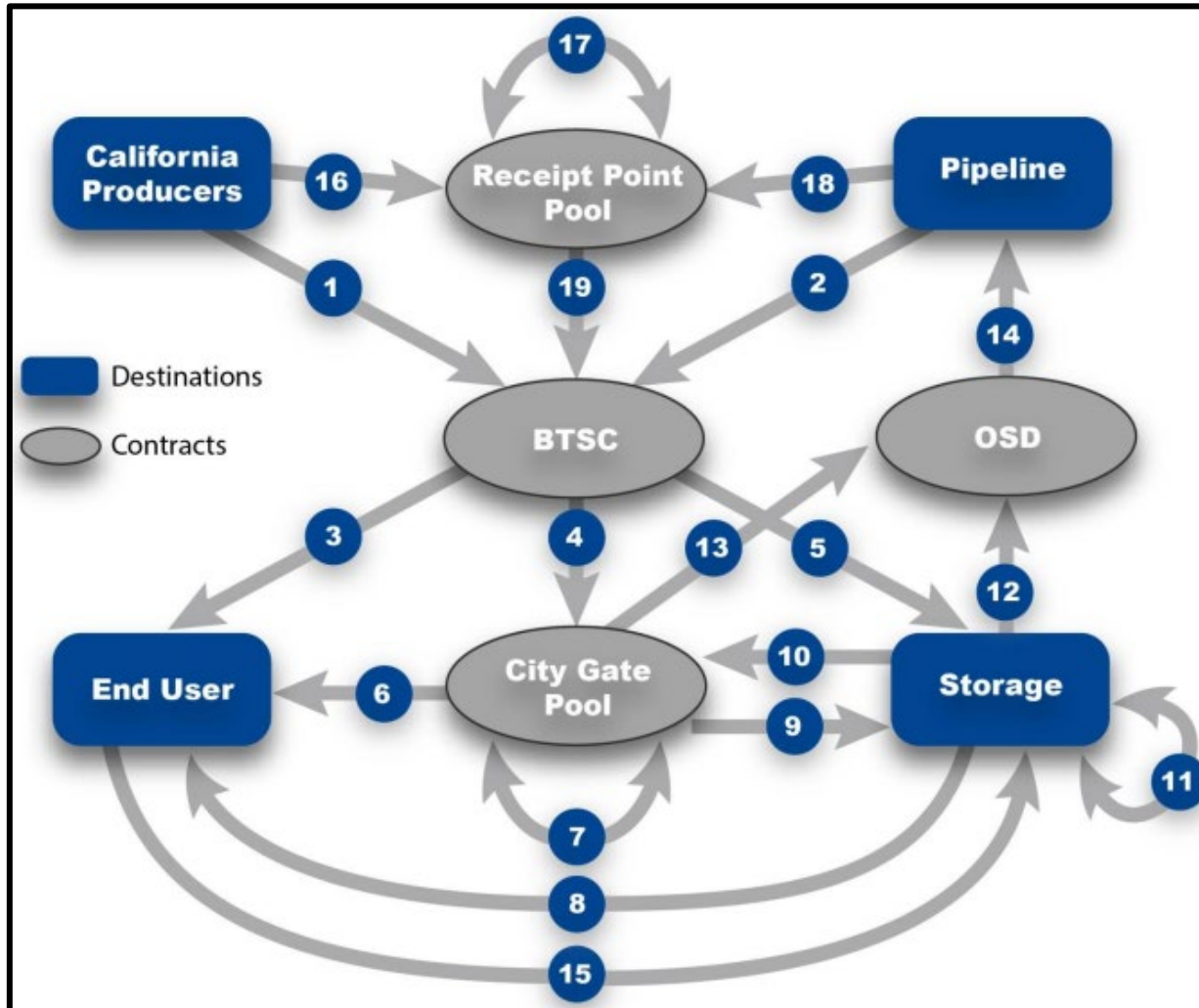


Backbone Transportation System Open Season 2026 Step 1

Who is Eligible to Buy BTS Rights?

- » Utility Core Procurement Group, Core Transportation Agents and Wholesale Customers for their core requirements (Core Balancing Agents)
- » Noncore End-use customers of SoCalGas, SDG&E, Southwest Gas and Long Beach
- » California Producers
- » Contracted Marketers
- » Any Creditworthy party



Historical Bidding Rights During the Open Season

- » Contracted Marketers are assigned bidding rights based on the historical usage of their noncore customers
- » If a noncore customer wants to retain their bidding rights they must complete an Opt-out form

Can a Third Party Manage Customer Owned BTS Rights?

- » BTS rights can be managed by either the customer's Contracted Marketer or another third party by completion of a customer signed Nominating and Trading form
- » BTS Rights can be sold or traded on Envoy after the Open Season process is completed
- » Max rate for sale of BTS is 125% of the applicable G-BTS1, G-BTS2 reservation/volumetric rate.
- » No reservation charge is applicable to the G-BTS5 rate.

Contracts & Forms for BTS Service

- » Receipt Point Master Agreement (RPMA) - Umbrella agreement between the customer and Utility for BTS service (requires additional credit)
- » BTS Opt-out form to move your bidding rights from your Contracted Marketer
- » Nomination and Trading Form allows a BTS holder to designate an agent to nominate or trade BTS on customer's behalf
- » Backbone Transportation Service Contract (BTSC) – electronic contract for BTS service at a specific receipt point

BTS Service Rates

» Hypothetical Rates Effective 10-1-2026*

- G-BTS1 – 100 % Reservation Rate
 - Reservation Charge: \$0.89609 per Dth per day

- G-BTS2 – Modified Fixed Variable (MFV)
 - Reservation Charge: \$0.71687 per Dth per day
 - Volumetric Charge: \$0.17922 per Dth

- G-BTS5 – 100 % Volumetric Rate
 - Reservation Charge: \$0.89609 per Dth per day

*Rates are subject to change at anytime



Revise/Delete a Submitted Bid

- » Bids may be deleted or revised before the current round is closed
- » All bids are deemed final upon the close of the applicable round and the bidder will be contractually liable for all BTS Receipt Point rights awarded to them
- » SoCalGas will provide confirmation to each bidder that its submitted bid(s) was received

2026 Open Season Step 1

Set-Asides: Pre-Open Season - Step 1 Core Balancing Agents

- » Step 1 set-asides are baseload only and can be taken in any amount from zero up to the maximum qualifying amount.
- » Any amount awarded in Step 1 cannot exceed average daily usage assigned in Step 2 for core balancing agents
- » Core Balancing Agents with qualifying upstream contracts with a minimum term of 12 months in effect 2 months prior to the Open Season start date.



Set-Asides: Pre-Open Season Step 1

CA Producers

- » California Producers receive a set-aside option for a quantity equal to the producer's peak month's daily average production over the most recent three-year period.
- » Peak month is defined as the month with the highest average daily volume.
- » The set-aside quantity shall be increased if the specific production is likely to increase and such forecasted increase can be justified by the producer.
- » California Producers may elect all or a portion of the set-aside quantity.
- » This set-aside applies to all production within SoCalGas service territory.



Set-Asides: Pre-Open Season - Step 1 PG&E G-XF Customers

- » PG&E customers with effective Commission-approved contracts for delivery at PG&E Kern River Station under PG&E G-XF Rate Schedule in effect at the time of implementation, shall have a set-aside option for access rights at PG&E Kern River Station.

Set-Asides: Pre-Open Season - Step 1

Rule 39 Interconnects

- » Parties who have provided funding under Rule No. 39, Access to the SoCalGas Pipeline System, for increased receipt point capacity shall receive a set-aside option prior to the first open season following completion of the facilities and each open season thereafter.
- » Such set-aside option shall equal the quantity of the increase in receipt point capacity funded.
- » The set-aside quantity at Otay Mesa shall be limited to 700 MMcfd of Displacement Receipt Point Capacity.
- » Rule 39 Receipt Point shippers who fund displacement capacity are limited to 5-years from the completion date of the facilities after which set-asides will be based on a quantity equal to the peak month's average daily delivery volume over the most recent 3-year period.

» Customer steps:

- Register for bidding system (Logon ID, RPMA, and Legal Entity entries are required)
- Await “Bidder” activation by Capacity Products
- View bidding rights
- Approve “Viewers”
- Submit bids
- Review, accept, or reject assignments
- Receive email confirmation of submitted bids and awards
- Receive electronic awards for BTSC
- Exchange receipt points (if necessary)
